

RELEASE AND WAIVER OF LIABILITY AGREEMENT

I, (“Participant”) _____, acknowledge that I have voluntarily applied to participate in any and all activities during the 2nd Annual Houston Homeless Run including but not limited to the 5 mile Walk or Run; 10 Mile Run or 1 mile Little Run in Hermann Square Park

I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS ACTIVITIES AND THAT I COULD BE SERIOUSLY INJURED OR EVEN KILLED. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

I verify this statement by placing my initials here: _____ **Parent or Guardian’s initials (if under 18):** _____ As consideration for being permitted by the Houston Homeless Run, the State of Texas (“State”), the County of **Harris** (the “County”), and any lessor of the fair premises (“Lessor”), to participate in these activities and use the Houston Homeless Run designated premises and facilities, **I forever release the Houston Homeless Run and/ or any of their sponsors, the State, the County, the Lessor, any Houston Homeless Run affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively “Releasees”)**from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE HOUSTON HOMELESS RUN, THE STATE, THE COUNTY, AND THE LESSOR, AND SIGN IT OF MY OWN FREE WILL.
